 $\gamma$  can be 1 or 2

Example:

**Models:**

FLS-2 $\alpha$ 0 $\beta$ -00 $\gamma$

FLS is the series name

$\alpha$  signifies R-Red, B-Blue, G – Green, Y – Yellow, W-white, lens color

$\beta$  signifies 1 -120 volt, 2 – 240volt, 9 – 48Vdc

$\gamma$  signifies 1- single mount, 2- double mount
