



## INTELLiLED DIALIGHT LIGHTING CONTROLS - END USER SOFTWARE LICENSE AGREEMENT

### Overview:

This document (the “**Licence**”) sets out the terms and conditions under which any end user may use any software, apps, or other computer code (the “**Software**”) provided by Dialight Corporation or its Affiliates (“**Dialight**”). “**Affiliate**” means in relation a Party, any entity (corporate or otherwise) which at any time controls, is controlled by or which is under common control with such Party, where “control” means the right to exercise, directly or indirectly, more than 50% of the voting securities of the Party or relevant entity or the ability, directly or indirectly, to control or determine the management or general business decisions of such Party or entity, whether by membership on the relevant board of directors or other governing body, by contract or by any other means. If the end user is an organisation, references to “**You**” or “**Your**” in this License shall mean collectively, the organisation and the end user of the software as named in the applicable invoice.

- 1. Acceptance of Licence Terms & Authority to enter Licence.** By installing or utilising the Software, You accept the terms of this Licence and will continue to meet Your obligations hereunder, including without limitation, Your obligation to pay for the Software. By installing or utilising the Software You also represent and warrant that you have the authority to enter into this License on behalf of the organisation and that organisation agrees, or shall be deemed to agree, to be bound by all the terms of the this License.
- 2. Grant of License.** Dialight hereby grants to You a non-exclusive, non-transferable, non-sublicensable and limited License to use the most recent version of the Software generally publicly available at the time of use, in object code form only, only in accordance with any documentation provided by Dialight, and solely for your internal business purposes at the specific site specified in the invoice (if any).
- 3. Third Party Use.** You may authorize third parties (other than those engaged in competitive activities with Dialight) to utilize the Software when those third parties perform activities solely in the furtherance of Your internal business purposes and only where You would have been Licensed to perform such activities under Section 2 above. Should You choose to so authorize such third parties, You shall ensure that they understand that their performance is subject to compliance with this License at all times and You shall remain primarily responsible for the behaviour of those third parties. Dialight retains the right to terminate third party use, including where authorized by You, at any time and for any reason.
- 4. Changes to Functionality or Ongoing Access.** Notwithstanding anything herein to the contrary, Dialight retains the right, in Dialight's sole discretion and at any time, to update and modify the Software, replace the Software with another product or service, and discontinue making the Software available (subject to an independent obligation to provide the Software for a specific term).
- 5. General License Restrictions.** You may only use the Software in accordance with the applicable documentation for such Software. The Software is protected under copyright, trade secret, and other intellectual property laws. You may not (a) sub-License, reproduce, distribute, market, sell, transfer, or disclose the Software or its documentation, (b) translate, modify, disassemble, or reverse engineer the Software or its documentation (except to the extent permitted by law), (c) create derivative works based on any portion of the Software or its documentation, (d) obtain possession of any source code or other technical material relating to the Software, (e) use the Software other than in accordance with the applicable documentation, (f) use the Software after expiration or termination of this License, (g) use the Software in a production environment for the benefit of a third party (including through the operation of a service bureau) or otherwise use the Software to directly generate revenue or otherwise directly commercially exploit the Software, (h) remove, alter, or obscure any copyright notice(s) or proprietary legend(s) contained on the media or included in the Software or its documentation, in each case as provided by Dialight, or (i) install, access, or use versions of the Software previous to the most recent version of the Software generally publicly available (other than for a reasonable time while transitioning to a newly released version). Unless agreed otherwise in writing by Dialight, You may not make any copies of the Software other than a single uninstalled copy of the Software solely for back-up or archival purposes.

- 6. High Risk Restriction.** You acknowledge and accept that Dialight did not design the Software and does not warrant the Software for use in developing, or for incorporation into, products or services relative to or within applications or environments requiring fail-safe performance, such as in the operation of nuclear facilities, aircraft navigation or communication systems, air traffic control, life support machines, surgically implanted devices, weapons systems, or other applications, devices or systems in which the failure of the Software could directly result in death, personal injury, or severe physical or environmental damage ("High Risk Activities"). Notwithstanding any other provision of this License, You may not use or authorize any third party to use the Software in connection with any High Risk Activity.
- 7. Ownership of Software.** The Software is not in the public domain. Dialight, its Affiliates, and/or its licensors are the owners of all intellectual property rights, including without limitation patent, trademark, copyright, and trade secret rights, in the Software, the corresponding documentation, and the techniques and ideas embodied and expressed in the foregoing, including the structure, sequence, and organization of the Software (collectively the "**Program Concepts**"). You acknowledge that, except for the limited License granted hereunder, You have no rights in or to the Software, any documentation, the Program Concepts or any copies thereof.
- 8. Proprietary Rights and Information.** You acknowledge and agree that the Software and all documentation and other information related thereto or disclosed or delivered to You in relation to this License ("**Dialight's Information**") represent Dialight's confidential and proprietary information. You agree to keep Dialight's Information confidential by exercising the necessary care required to prevent its disclosure. Notwithstanding the above, You will not disclose, divulge, distribute, publish, transmit, or transfer Dialight's Information to any third party or use Dialight's Information for any purpose whatsoever other than as expressly authorized by this License. Your obligations with respect to Dialight's Information deemed "trade secrets" under applicable law shall remain in effect for as long as Dialight's Information remains a trade secret. Your obligations with respect to Dialight's Information that is not deemed to be a trade secret shall remain in effect for a period of three (3) years following the last day you receive any of Dialight's Information.
- 9. Your Data.** With respect to data entered into the Software or which Dialight may access through its performance of related services for You (e.g., maintenance or support) (collectively "**Your Data**"), you agree and acknowledge that You are solely responsible for the content of such data. You represent and warrant to Dialight that you shall obtain all Licenses and permissions needed to provide and/or License Your Data to Dialight as provided below. You represent and warrant to Dialight that providing and/or licensing Your Data to Dialight under this License shall not violate any applicable law, including specifically European Union Regulation (EU) 2016/679 (General Data Protection Regulation) or right of any third party. You agree and acknowledge that You are solely responsible for ensuring that You maintain proper backup or documentation necessary to enable You to recover Your Data in the event of corruption or data loss. Dialight is not acting as a disaster recovery provider for You and shall not be liable for the loss or replacement of Your Data.
- 10. License to Your Data.** You hereby License Dialight the right to utilize Your Data for the purpose of performance of Dialight's obligations to You under this License. Additionally, you hereby License Dialight to use Your Data to contact You regarding other products and services that Dialight may offer on its own behalf or on behalf of others. Additionally, you hereby License Dialight the right to extract from Your Data certain information that, either alone or in conjunction with other information which Dialight may decide to include, can be used to make up anonymized data sets which Dialight may use for any lawful purpose in perpetuity. For the purposes of this License, anonymized data sets may include any of Your Data on an aggregated basis except (a) Your information which is protected by a separate License agreement between You and Dialight, (b) information that can readily be used to identify a specific individual's identity, either alone or when combined with other information from another source, (c) protected health information which has not been de-identified in accordance with 45 CFR 164.514 or other applicable law, prior to incorporation in the anonymized data set, or (d) information which can be used to easily identify You as the source.
- 11. General Warranty Disclaimer.** The Software is Licensed to You on an "as is" basis and Dialight disclaims any and all warranties, whether express or implied, including without limitation, any warranties of merchantability, warranties in respect to third party software, fitness for a particular purpose, and non-infringement. Without limiting the foregoing, You agree that Dialight and its officers, directors, agents, and employees, shall have no liability for errors or omissions in (a) the output of the Software, such outputs including, without limitation, the quality or accuracy of any screen displays or reports, (b) the operation of third party equipment controlled by the Software, (c) the transmission and reception of data, or (4) the processing of data by the Software. Dialight does not represent or warrant that the Software will operate continuously or error free. You expressly accept that the installation, establishment, and maintenance of proper

safety controls and procedures and proper monitoring and operation of all equipment within Your control is Your responsibility and not that of Dialight, and hereby waive any claims of liability of Dialight to any damages that may result from such operation. Reliance upon the Software shall not be considered a basis for transferring any portion of such responsibility to Dialight nor a basis for contributory or comparative liability.

- 12. Special Warranty Disclaimer.** Without modification to Section 10, You agree and acknowledge that Dialight is providing You with the Software as a tool which is to only be used by an individual of appropriate training and expertise as an adjunct to his or her professional judgment. Such individual shall be solely responsible for reviewing all data put into and all data extracted from the Software to ensure that it meets all applicable professional standards and legal requirements as well as Your needs and intent. Dialight does not represent or warrant and expressly disclaims that (a) the Software will properly scale or translate data between different software programs or data formats, and (b) the Software will conform any output to meet any professional standards or legal requirements.
- 13. Limitation on Types of Damages.** IN NO EVENT WILL DIALIGHT OR ITS AFFILIATES, OFFICERS, DIRECTORS, AGENTS, AND EMPLOYEES, BE LIABLE TO YOU FOR CONSEQUENTIAL, EXEMPLARY, INCIDENTAL, OR INDIRECT DAMAGES OR COSTS (INCLUDING LEGAL FEES AND EXPENSES) OR LOSS OF GOODWILL OR PROFIT IN CONNECTION WITH THE SUPPLY, PERFORMANCE, USE OF OR INABILITY TO USE THE SOFTWARE OR IN CONNECTION WITH ANY CLAIM ARISING FROM THIS LICENSE, EVEN IF DIALIGHT HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES OR COSTS.
- 14. Limitation on Total Damages.** THE MAXIMUM AGGREGATE AND CUMULATIVE LIABILITY OF DIALIGHT FOR ANY AND ALL CLAIMS UNDER THIS LICENSE, REGARDLESS OF THE THEORY OF LIABILITY, SHALL BE THE TOTAL AMOUNT RECEIVED BY DIALIGHT, FROM YOU, FOR THE LIGHTING CONTROLS SYSTEM DURING THE PRIOR TWELVE (12) MONTHS BEFORE ANY SUCH CLAIM IS MADE. BEFORE ANY SUCH NO ACTION ARISING OUT OF THIS LICENSE, REGARDLESS OF FORM, MAY BE BROUGHT MORE THAN ONE (1) YEAR AFTER THE DATE THE CAUSE OF ACTION HAS ACCRUED. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATION OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES UNDER CERTAIN CIRCUMSTANCES, SO THIS PARAGRAPH MAY NOT APPLY TO YOU.
- 15. Indemnification.** You agree to indemnify, defend, and hold harmless Dialight and its respective officers, directors, employees, agents, successors, representatives and assigns from any suits, losses, claims, demands, liabilities, costs and expenses (including attorney or accounting fees) sustained, incurred, or arising from (a) Your use or misuse of the Software or Program Concepts, including any output therefrom, and (b) Your violation of any term of this License.
- 16. Verification.** On the reasonable request of Dialight, You shall furnish Dialight with a signed statement that the Software and the Program Concepts are being used pursuant to the terms and conditions of this License. You hereby grant Dialight the right to conduct a general audit to ensure the terms of this License are being adhered, pursuant to which you shall permit Dialight appointed personnel to review Your relevant records and inspect Your facilities to ensure compliance with this License. Dialight will conduct such inspection with reasonable notice, during normal business hours in a manner that does not unreasonably interfere with Your business operations.
- 17. Term and Termination.** This License shall become effective when You or someone acting on Your behalf first installs the Software, or first utilizes the Software for any purpose. This License shall continue in full force so long as the Software remains installed unless it is terminated earlier as set forth herein. This License shall automatically terminate should You voluntarily or involuntarily become insolvent or subject to the jurisdiction of any bankruptcy court. Dialight hereby reserves the right to terminate this License upon written notice at any time. Upon termination of this License for any reason, You shall immediately return the Software and any copies, together with all related documentation to Dialight, or, at Dialight's discretion, You shall permanently uninstall and destroy all copies of the Software and any related documentation in Your possession or control. Upon termination or expiration of this License all sections of this License which by their nature should survive shall continue in full force and effect, including without limitation Sections 4 - 25.
- 18. U.S. Government Restricted Rights.** The following applies to all acquisition of the Software by or for the U.S. government or by any prime contractor or subcontractor under any contract, grant, or other activity with the U.S. government. The Software and services related to such Software provided to You hereunder are "commercial

items" as that term is defined at 48 C.F.R. 2.101 (October 1995) consisting of "commercial computer software" and "commercial computer software documentation" as such terms are used in 48 C.F.R. 12.212 (Sept. 1995) and other applicable acquisition regulations and are provided to the U.S. Government only as a commercial item. Consistent with 48 C.F.R. 12.212 and 48 C.F.R. 227.7202 (June 1995), all U.S. Government users and licensees acquire the Software and its associated documentation with only those rights and subject to the restrictions set forth in this License. Notwithstanding the foregoing, the Software may not be acquired by the U.S. government pursuant to a contract incorporating clauses prescribed by FAR Subpart 27.4 (June 1987) or DFARS Subpart 227.4 (Oct. 1988). If this License is inadequate to meet the government's needs or is inconsistent in any respect with Federal law, the government should return the Software, unused, to Dialight.

- 19. Injunctive Relief.** You acknowledge that remedies at law shall be inadequate to provide Dialight with full compensation in the event of Your material breach of this License, and that Dialight shall therefore be entitled to injunctive relief in the event of any such material breach without the need to post bond or prove the inadequacy of monetary damages. Regardless of any provisions to the contrary, Dialight shall have no obligation to allow You to cure Your breach prior to seeking injunctive relief and shall be entitled to seek such injunctive relief in any jurisdiction regardless of any choice of law or venue provisions.
- 20. Governing Law.** This License shall be construed and governed in accordance with the laws of the State of Jersey, without regard to its rules regarding conflicts of law. Neither the Uniform Commercial Code, any part of the Uniform Computer Information Transactions Act (if adopted), nor the United Nations Convention on the International Sale of Goods shall apply to the Software or this License. You agree to submit to the personal and exclusive jurisdiction of the state and federal courts located within the State of New Jersey.
- 21. Compliance with Laws and Export Rules.** You shall be solely responsible for ensuring that Your use of the Software, documentation, and Your Data is in full compliance with all applicable laws and without violation of the rights of third parties, including explicitly the EC General Data Protection Regulation. Without limiting the foregoing, You represent and warrant that the Software and documentation will not be exported to, or used by, nor will the data gained therefrom be exported to, transshipped or re-exported to (a) any individual located in any nation to which export, transshipment, or re-export is prohibited by U.S., UK or EU law or regulation at that time (collectively, the "**Restricted Nations**"); (b) any business or organization owned, controlled by or acting on behalf of an individual, business or organization in a Restricted Nation; (c) the governments of a Restricted Nation or any business or organization owned, controlled by or acting on behalf of a government of a Restricted Nation; or (d) any individual, group or organization on the U.S. Department of Treasury's Office of Foreign Assets Control's list of Specially Designated Nationals or the U.S. Department of Commerce's Bureau of Export Administration's List of Denied Persons, as each may be amended from time to time.
- 22. Waiver / Severability.** The failure of Dialight to exercise or enforce any right or provision of this License shall not constitute a waiver of such right or provision. Should any court or legal authority hold any provision of this License unenforceable or invalid for any reason, then You and Dialight agree that such court or authority shall attempt to craft an acceptable provision most closely resembling the intent of the offending provision, and if such court or authority is unable or unwilling to do so then this License shall be construed as if such provision were never contained in this License.
- 23. Assignment.** You cannot assign, sub-license, or transfer this License without the prior written consent of Dialight. Any attempt by You to sub-license, assign, or transfer any rights, duties, or obligations hereunder is null and void. Dialight may assign, sub-license, or transfer this License, in whole or in part, at will and without notice to You.
- 24. Merger.** This License comprises the entire agreement between You and Dialight with respect to the Software, documentation, and related services ("**Agreement**"), and supersedes any other agreement or discussion, oral or written, with respect to the Software, documentation, and related services. If another written agreement signed by

Dialight and You both governs the Software and expressly and unambiguously states that this License, by specific reference, is subservient to that agreement, then that agreement and this License, interpreted together in accordance with Section 23, shall constitute the Agreement.

**25. Electronic Execution.** By installing or otherwise making use of the Software You hereby agree to transact business with Dialight electronically.
