7. <u>Personal Data Retention Periods</u>:

Except as otherwise permitted or required by applicable law or regulation, Dialight only retains personal data for as long as necessary to fulfil the purposes Dialight has collected it for, as required to satisfy any legal, accounting, or reporting obligations, or as necessary to resolve disputes.

To determine the appropriate retention period for personal data, Dialight considers the amount, nature, and sensitivity of personal data, the potential risk of harm from unauthorized use or disclosure of personal data, the purposes for processing the personal data, whether the employer can fulfil the purposes of processing by other means, and any applicable legal requirements.

Dialight typically retains personal data for the periods set out below, subject to any exceptional circumstances or to comply with laws or regulations that require a specific retention period:

- Information about customers:
 - Personal details including name and contact information: for as long as they are an active customer of Dialight plus four years.
 - User activity details and user preferences: for as long as they are an active customer of Dialight plus four years.
 - Location details: for as long as they are an active customer of Dialight plus four years.



- Electronic identification data including IP address and information collected through cookies: for as long as they are an active customer of Dialight plus four years.
- Contractual details including the goods and services provided: for as long as they are an active customer of Dialight plus four years.
- Information about employees and job applicants:
- Personal details including name and contact information: for the duration of time they are an active supplier for Dialight plus four years.
- date of birth: 6 years post leave date.
- marital status: 6 years post leave date.
- beneficiary and emergency contact information: 6 years post leave date.
- government identification numbers: 6 years post leave date.
- education and training details: 6 years post leave date.
- bank account details and payroll information: duration of employment.
- wage and benefit information: 6 years post leave date.
- performance information: duration of employment.
- employment details/contract of employment: 6 years post leave date.
